



Information about invoice requirements

All Bonava companies have specific invoicing addresses and require mandatory information to process an invoice for payment in time.

Invoice information needed:

- **Invoice recipient:** The name of the buying Bonava company.
- **Invoicing address** to the buying Bonava company, see enclosed table.
- Mandatory reference number which is a Bonava **project cost centre**, PCC, (potentially also account number).
The reference number should be supplied by your contact at Bonava and stated in the upper part of the invoice.
It should be without space, hyphen, or any other character.
- **Payment information** e.g. bank account, IBAN and Swift.
- Your company **registration number**.
- If the invoice is subject to **reversed VAT**:
The information text below should be stated together with VAT number of the ordering Bonava company.
"Reversed tax liability for construction services applies"
